<sup>1</sup> For the first month, the Account maintenance fee shall be charged on a pro-rata basis according to the number of days the Account was active. The fee for the preceding month shall be charged on the first day of the subsequent month.

<sup>2</sup> Including system setup, ongoing maintenance, access rights adjustments, Authorized User(s) additions and related administrative services.

<sup>3</sup> A payment order for funds transfer within Solidgate will be processed no later than the next business day following its receipt.

<sup>4</sup> A SEPA payment is made if the beneficiary’s bank has joined the pan-European payment system STEP2 SCT. SEPA payment is made as instant payment if the payment amount is up to EUR 100,000 and the beneficiary’s bank has joined the pan-European instant payment system RT1 or TIPS.

<sup>5</sup> If Solidgate receives a payment order before the cut-off time (Cyprus time), it will be processed within Solidgate’s business day and no later than the applicable value date for the specific payment type. Payment orders received after the cut-off time or outside a business day will be deemed received on the next business day and processed accordingly.

<sup>6</sup> “T” value date means that Solidgate transfers funds to a recipient bank on the date of processing a payment order.
